Frequently Asked Questions

1. Why do I need to terminate my existing factory registration or notification?

Under the Workplace Safety and Health (Registration of Factories) Regulations, if your company has stopped operations or ceased to occupy your factory premises, you should terminate your Factory Notification or Registration. Please refer to MOM website for more information. (<u>https://www.mom.gov.sg/workplace-safety-and-health/factory-notification-and-registration/terminate-a-factory-notification-or-registration</u>)

2. How do I terminate my factory registration or notification?

You can terminate your workplace as a factory via the Gobusiness online portal at the URL (https://licence1.business.gov.sg/feportal/web/frontier/home).

Please note the following points:

- Only personnel authorised by the company should perform transactions on behalf of the company.
- A valid CorpPass account is required to login for the submission.
- You are required to have a valid Registration for Companies/Business and furnish a valid Unique Entity Number (UEN).
- No fee payment is required for termination transaction. Termination is immediate and does not require processing by officers.
- Please note your statutory equipment (e.g., pressure vessels or lifting equipment) at the factory will also be automatically deregistered when you terminate your Factory Notification or Registration.
