Before you start

If you have all the right information on hand, this form should take 5 minutes to complete.

You will need:

- The foreign domestic helper's Work Permit number and the date of Work Permit application
- The employer's NRIC number or Foreign Identification Number (FIN)
- Personal details of family members living in the same household

Make sure you meet the eligibility criteria on **page 3** and provide the correct supporting documents when you apply.

Complete and submit the form using iSubmit – select option 9: Levy matters.

Eligibility Criteria for Levy Concession

Use this guide to find out when you are eligible for levy concession and whether you need to apply for the concession.

For a young child

You (the FDW employer) or your spouse has a child or grandchild **living with you**.

Your child is:

- Below 16 years old
- A Singapore citizen
- Living with you

Young child scheme

You do not need to apply. We will grant you the concession based on information you provided when you applied for an FDW.

Your grandchild is:

- Below 16 years old
- A Singapore citizen
- Living with you

Young grandchild scheme

Use this form to apply for levy concession.

For aged persons

You (the FDW employer) are aged 65 and above, or have an elderly family member **living with you**. You are also eligible if one of you is a Singapore citizen and the other is a Singapore permanent resident (PR).

You or your spouse is:

- Aged 65 years or above
- A Singapore citizen / PR
- Living at the same NRIC-registered address as the employer

Aged employer/spouse scheme

You do not need to apply. We will grant you the concession based on information you provided when you applied for an FDW.

Your parent, parent-in-laws, grandparent or grandparent-in-laws is:

- Aged 65 years or above
- A Singapore citizen / PR
- Living at your NRIC-registered address

Aged parent/grandparent scheme
