



# Review your crisis preparedness plans through common simulation exercises

Plan ahead for business continuity to enhance your ability to react to business disruptions. We have listed below three measures which can help your workplace to be more resilient in the face of sudden threats or crises. Do consider how you may adapt the ideas to suit the needs of your organisation.

Practise what to do in an emergency and familiarise employees with escape routes, hiding places, and safety procedures. Use drills to identify gaps in contingency plans.







Review and learn from terror incidents shared via the SGSecure@Workplace bulletins. Reviewing these incidents will enable teams to better understand the circumstances that led to the incident, consider how their own organisations would have responded to the incident, and surface relevant points to improve their own plans.

Form a designated team to identify and assess vulnerabilities of the security system. The team can test the ability to detect an attack, respond and minimise or negate its effect. Red-teaming can help provide a realistic analysis of how breaches may occur and provide valuable insight to the impact on business.
