**Professor Tan Chorh Chuan (陈祝全)**  
**Chairman, CPF Advisory Panel**  
**President of National University of Singapore**

Professor Tan Chorh Chuan is President of the National University of Singapore. He concurrently serves as the Chairman of the Board of the National University Health System and as Deputy Chairman of Singapore's Agency for Science, Technology and Research (A\*STAR). He is also a member on the Board of Directors of the Monetary Authority of Singapore.



**Professor Joseph Cherian**  
**Practice Professor of Finance, NUS Business School**

Professor Joseph Cherian is Practice Professor of Finance and Director of the Centre for Asset Management Research & Investments at NUS Business School. **President, Singapore Council of Women's Organisations**
