

ADDENDUM TO THE TRIPARTITE CLUSTER FOR CLEANERS RECOMMENDATIONS ON THE ENHANCED TRAINING REQUIREMENTS FOR THE CLEANING INDUSTRY

1. BACKGROUND AND OVERVIEW

- 1.1 On 7 June 2021, the Tripartite Cluster for Cleaners (TCC) released its recommendations on the review of the Progressive Wage Model (PWM) for the cleaning Industry. The TCC had recommended enhancing the PWM training requirements whereby the total number of Workforce Skills Qualification (WSQ) training modules will be further increased from 2 modules (one mandatory Workplace Safety and Health (WSH) module and one core module) to 3 for the lower PWM job rungs and 4 modules for the higher job rungs. This addendum addresses additional training requirements beyond the existing requirements that took effect from 31 Dec 2022.
- 1.2 To provide sufficient lead time for the industry to meet the updated Enhanced Training Requirements (ETR), the TCC had proposed for the ETR to take effect sometime beyond year 2025. The TCC recommendations were accepted by the Government and were implemented under the cleaning business licensing regime through the Order imposed by the Commissioner for Labour.
- 1.3 This addendum report sets out the implementation timeline of the ETR and an updated list of WSQ training modules for the respective job roles.
- 1.4 The members of TCC are listed in Annex A.

2. PWM SKILLS LADDER – ENHANCED TRAINING REQUIREMENTS FOR THE CLEANING WORKFORCE

- 2.1 The TCC recognised the importance of continuous learning and upskilling to ensure the cleaning workforce can keep pace with industry transformation as the sector moves towards greater use of technology-enabled solutions to improve productivity.
- 2.2 The TCC had previously recommended that the number of WSQ training modules be increased as follows:

PWM Job Roles	By 31 December 2022	Beyond 2025
• All Cleaners	1 Mandatory WSH Module + 2 Core Modules = 3 modules in total	1 Mandatory WSH Module + 2 Core Modules = 3 modules in total
• Multi-skilled Cleaners • Mechanical Driver • Supervisor • Truck Drivers	1 Mandatory WSH Module + 1 Core Module = 2 Total	1 Mandatory WSH Module + 3 Core Modules = 4 modules in total

2.3 In consultation with industry stakeholders, the TCC recommends for the ETR implementation to take effect from **1 July 2027**. This would give sufficient lead time to both employers, training providers and workers to schedule and attend the additional training modules respectively.

2.4 The TCC would also like to urge service buyers to allow their service providers to send their workers for training during working hours as long as service standards are not compromised. Service buyers are encouraged to be more empathetic towards their service providers and are advised to engage in open communications to achieve amicable arrangements.

2.5 Cleaning businesses may select the additional training modules from the list of endorsed WSQ core modules that are mapped to the respective Technical Skills & Competencies (TSCs).

2.6 The TCC will periodically review the list of WSQ modules to ensure continued relevance and to facilitate cleaning businesses in sending their workers for the requisite training under the ETR.

2.7 The TCC strongly recommends cleaning businesses to consider the following WSQ modules with the respective TSCs for the different PMW job roles as these modules form the core skillsets that the cleaning workforce should be equipped with to carry out their work competently:

It will engage the industry stakeholders in the months ahead and announce its recommendations on an Enhanced Career Ladder when ready.
- 3.3 The TCC also would like to call upon the whole-of-society to recognise and appreciate the hard work of the cleaning workforce. They play an essential role in ensuring everyone can live, work and play in a clean and safe environment.
