## PROFILE OF WSH COUNCIL MEMBERS



Mr Lee Tzu Yang Chairman, WSH Council Chairman, Shell Companies in Singapore

Mr Chia Ngiang Hong has more than 30 years of experience in the real estate and construction industry. He graduated from the University of Singapore with a degree in Bachelor of Science (Estate Management) (Honours). He subsequently obtained his Master in Business Administration (with Distinction) from the University of Hull, UK.

Mr Chia was the Property Manager with DBS Land before joining City Developments Limited (CDL) in 1981 where he is currently the Group General Manager. He holds several other positions in different organizations, such as:

- Fellow in the Singapore Institute of Surveyors & Valuers (SISV)
- First Vice President of Real Estate Developers' Association of Singapore (REDAS)
- Member of the Advisory Panel in BCA Academy
- Chairman of the Consultative Committee to the Department of Real Estate, National University of Singapore (NUS)

Under Mr Chia's leadership, CDL has been championing a Safe and Green culture in its operations which stems from its firm advocacy in Corporate Social Responsibility since the late 1990s. It is the first and only Singapore private developer certified with OHSAS 18001 for occupational health and safety management in 2003. CDL has committed itself to create a holistic safety and health management system which integrates product and service delivery and transcends across the whole value chain. It introduces numerous initiatives in this aspect including the well-known CDL 5-star Environment, Health & Safety (EHS) Assessment System.

In recognition of these efforts, CDL was awarded the inaugural Developer Award by the Singapore's Ministry of Manpower (MOM) in 2006. CDL's commitment in WSH has also been recognized internationally, having been conferred the prestigious UK RoSPA (The Royal Society for the Prevention of Accidents) Gold Award for 3 consecutive years since 2006.

Mr Ho Siong Hin Member, WSH Council Commissioner for WSH, Ministry of Manpower

Mr Ho Siong Hin is the current Commissioner for Workplace Safety and Health. He holds a concurrent position as the Divisional Director for the Ministry of Manpower's Occupational Safety and Health (OSH) Division. Mr Ho was instrumental in the formation of the WSH Council and will now serve as a member of the Council.

Mr Ho is a Mechanical Engineering graduate from the University of Auckland, New Zealand. He joined MOM in 1982 as a Factory Inspector which involves inspection of workplaces, investigation of industrial accidents, pressure vessels and lifting equipment. Subsequently, Mr Ho held various portfolios in MOM, including Deputy Director of Construction, Shipyards and Engineering, Director of Corporate Planning and Divisional Director for Foreign Manpower Management Division. For his contribution to the public service, Mr Ho received his National Day Awards, PPA (Silver) in 2000.

In 2005, Mr Ho was appointed to his current position to lead OSH reform in Singapore. Arising from the Ministerial Study Trip to Europe to learn OSH best practices, Mr Ho played a key role to translate the findings of the study mission to a new OSH framework announced in Parliament in March 2005. The key changes include a push for greater ownership by industry for OSH outcomes and the introduction of risk management.

Mr Ho continued to lead major OSH developments, including the introduction of the new WSH Act in 2006, enhanced capabilities in inspections and investigations and new industry engagement programmes such as bizSAFE and ConSASS. Under Mr Ho's leadership, a new online reporting system known as iReport was also launched to make simple the reporting of accidents. All these efforts had led to the significant reduction in the fatal accident rates from 4.9 deaths per 100,000 workers in 2004 to 2.9 deaths per 100,000 workers in 2007.

In the regional and international arena, Mr Ho has presented many papers on OSH matters, including China, Hong Kong and Australia. Mr Ho is also an active member of the ASEAN OSHNET. In particular, he chaired the ASEAN Policy Dialogue on implementing OSH Framework among ASEAN member countries in 2007. An important achievement at this dialogue was the agreement by all ASEAN member countries to implement the OSH framework within a specific time frame.

Beyond his MOM portfolio, Mr Ho is a member of the Professional Engineers Board and an Advisory Committee member to the Chemical Engineering Department of Ngee Ann Polytechnic. He is also a member of the Singapore Accreditation Council by SPRING and chairs the Council Committee on Inspection Bodies. He serves as a Council Member of the Institution of Engineers Singapore and chairs the membership committee.



Mr Karthikeyan s/o R. Krishnamurthy Chairman, WSH Council (Chemical Industries) Committee General Secretary, United Workers of Petroleum Industry

Mr Karthikeyan, under the Petrochemical Corporation of Singapore (PCS), is currently seconded to United Workers of Petroleum Industry (UWPI) as General Secretary.

He has been seconded to Singapore Petrochemical Complex Employees Union (SPCEU) and then to UWPI for 25 years. During the tenure, he served in many committees and the first committee he volunteered to serve in was the safety committee in PCS, in which he served from June 1985 to May 1986. After that sojourn, he requested companies that Union committee should sit-in the committee every year. Presently, Mr Karthikeyan is serving as NTUC Workplace Health and Safety Committee as Chairman. He is also in the NTUC Central Committee and servings the NTUC Thrift and Loan, Shell Thrift and Loan and Workforce Development Agency as Board Member.

Mr Karthikeyan was a member of the WSH Advisory Committee and now serves as Chairman of the WSH Council (Chemical Industries) Committee.

Associate Professor Lim Meng Kin Chairman, WSH Council (Healthcare) Committee Department of Epidemiology and Public Health, Yong Loo Lin School of Medicine, National University of Singapore (NUS)

Dr Lim Meng Kin is Associate Professor of Health Policy and Management at the Yong Loo Lin School of Medicine, National University of Singapore. He is concurrently Academic Director of the MBA (Healthcare Management) Program at the NUS Business School, and Public Health Director of the Association of Pacific Rim Universities' World Institute. He was formerly Chief of the Singapore Armed Forces Medical Corps, founding Director of the Defence Medical Research Institute and Chief Executive Officer of the Health Corporation of Singapore.

Assoc Prof Lim obtained his medical degree (with distinction in Social Medicine & Public Health) from the University of Singapore in 1974, followed by the Diploma in Aviation Medicine (UK) in 1977, MSc Occupational Medicine (Singapore) in 1982, and MPH in Health Policy and Management (Harvard) in 1990. He is an elected Fellow of the Royal College of Physicians of Edinburgh, the Faculty of Occupational Medicine, UK, and the Academy of Medicine of Singapore.

Assoc Prof Lim has served as Board Director of Singapore General Hospital, Tan Tock Seng Hospital, Changi General Hospital, KK Women and Children's Hospital, Singapore National Eye Centre, National Heart Centre, National Neuroscience Institute, and Ang Mo Kio Community Hospital. He has also served on numerous national health committees such as Radiological Protection, HIV Control, Tuberculosis Control, Epidemic Diseases, Smoking Control, Healthy Lifestyle Promotion, and the Subcommittee on Hub Services of the Committee on Singapore's Competitiveness.

Assoc Prof Lim is currently Visiting Consultant in Occupational Medicine to the Singapore General Hospital and a board member of the Singapore Medical Association's Centre for Medical Ethics and Professionalism. He is also Council Member of the Singapore Red Cross, Chairman of its Disaster Preparedness Committee, and Vice-Chairman of the Tsunami Reconstruction Facilitation Committee.

Internationally, he has served on the WHO Western Pacific Advisory Committee on Health Research and has consulted extensively for the World Bank, World Health Organization and Asian Development Bank across Asia and the Middle-east (China, Vietnam, Thailand, Indonesia, Malaysia, Brunei, Bulgaria, Lebanon, Kuwait, Egypt, and West Bank and Gaza. Iran). He is on the editorial boards of *Health Services Research*, *Health Research Policy and Systems* and *Asian Journal of Health and Information Sciences*. Amongst his awards are the Public Service Star, Public Administration (Silver) Medal, and NUS's Special Commendation Award for Teaching Excellence.

Professor Low Teck Seng Chairman, WSH Council (Metalworking and Manufacturing) Committee Deputy Managing Director (Research), Agency for Science, Technology and Research (A\*STAR)

Prof Low graduated with First Class Honours in Electrical & Electronic Engineering in 1978 from Southampton University and subsequently received his PhD from the same university in 1982, specializing in computational electromagnetics. He was a Research Fellow at Southampton University from 1981 to 1983. He joined National University of Singapore (NUS) in 1983 as an academic staff of the Department of Electrical Engineering. His research interests were in magnetics and their applications to data storage and in recent years his interests included aspects of nanomagnetics. He has published over 100 research papers in internationally refereed academic journals and conferences. He is a recognised expert in the design and control of permanent magnet machines.

Prof Low was tasked to set-up the Magnetics Technology Centre (MTC) at NUS in 1992 with the support of a research grant from the National Science and Technology Board (NSTB). This served as the anchor for technology development, partnerships and acted as the catalyst for R&D in the data storage serving an industry sector of prime importance to Singapore. The MTC was renamed the Data Storage Institute (DSI) with an expanded charter in 1995, and is today the foremost research centre in data storage technologies in the world focusing on technologies in magnetics and optics relevant to data storage.

In 1998, Teck Seng returned to the Faculty of Engineering at BUS as Dean. As NUS was preparing at that time for the new challenges of the emerging knowledge economy, he was instrumental in establishing clear developmental strategies for the faculty and oversaw the partnerships with MIT, Technical University Eindhoven and Georgia Institute of Technology.

During his tenure as Dean he initiated four faculty level multi-disciplinary laboratories, the Laboratory for Concurrent Engineering and Logistics (LCEL), the Laboratory for Biomedical Engineering (LBME), the Large Scale Systems Laboratory (LSSL) and the Information Storage Materials Laboratory (ISLM).

In 2001, Prof Low served as Chairman of the Task Force looking into the establishment of a fifth polytechnic in Singapore which led him to be the founding Principal of Republic Polytechnic in 2002. Under his leadership, RP introduced Problem-Based Learning pedagogy and full-fledged holistic learning experience, this unique approach has gained international recognition.

Prof Low was awarded the National Science and Technology Medal in 2004, the highest honour bestowed on an individual who has made distinguished, sustained and exceptional contributions, and played a strategic role in the development of Singapore through the promotion and management of R&D.

In 2007 he was awarded the Public Administration Medal (Gold) by the President of Singapore for his outstanding contributions to the development of technical education and the management of science and technology for the nation.

Prior to joining A\*STAR as the Dy Managing Director (Research) in Apr 2009; and appointed as Executive Director (Science & Engineering Research Council) in Feb 2010, Prof Low was the Chief Executive Officer of Parkway Education, a subsidiary of Parkway Health Group from Apr 2008.

On 22 Jul 2009, Prof Low was conferred the Honorary Doctor of Science by Southampton University in recognition for his contributions to Singapore and his profession internationally, in the IEEE.

In Jan 2010, Prof Low took up a tenured professorship at NTU and was appointed the Senior Advisor to President, Nanyang Technological University.

Prof Low currently sits on the following Board/Council:

- Member, Evaluation Committee for the Innovation for Environmental Sustainability (IES) Fund, National Environment Agency (NEA)
- Member, Workplace Safety and Health Council

Prof Low is a Fellow of the IEEE and he continues to be active in research. His technical interests are in computational electromagnetics, mechatronics and data storage technologies.

Professor Poo Aun Neow Chairman, WSH Council (Marine Industries) Committee Director, Bachelor of Technology Programme, Faculty of Engineering, NUS

Dr Poo Aun Neow received his B.Eng. degree with first class honours in mechanical engineering from the National University of Singapore in 1968. He then proceeded, on a Ford Foundation Fellowship, to the University of Wisconsin where he obtained his M.Sc. and Ph.D. degrees in 1970 and 1973 respectively. After a year as a research fellow with IBM's Thomas Watson Research Centre in New York, he joined the National University of Singapore (NUS) where he is currently professor in the Department of Mechanical Engineering. At NUS, he has held, amongst others, the positions of Head of the Department of Mechanical and Production Engineering, Dean of the Faculty of Engineering, and Director of the Graduate School of Engineering. He is currently Director of the Bachelor of Technology Programme. He is a member of the Senate at NUS and has also been on the Council of both NUS and NTU.

Prof Poo's special interest is in automation and mechatronics, a field in which he has worked for more than thirty years, supervised some dozens of doctoral and masters students, published some 250 research papers in journals or presented at international conferences, holds several patents, and consulted for industry. He has also been actively involved in organising numerous international conferences on automation, robotics and control, and served as editor to several international journals.

Other than his academic interests, Prof Poo is a past president and a Fellow of the Institution of Engineers, Singapore, and a Founding Fellow of the Asean Academy of Engineering and Technology. He has also served on the boards of management of numerous industrial and professional bodies including on Singapore Aerospace Industries, Singapore Institute of Standards and Industrial Research, the Defence Science Organisation, the International Federation of Robotics, and GINTIC Institute of Manufacturing Technology.

Besides his appointment by the Minister for Manpower as a Member of WSH Council, he is an Authority Member, Civil Aviation Authority of Singapore and sits on the Governing Council of the Institute of Service Excellence at SMU and Customs Advisory Committee as member.

At Keppel Logistics, where he retired on 31 December 2009, Mr Quek ensured that WSH activities were regularly held to promote WSH and the systems, processes and WSH framework were ISO and OHSAS 18001 certified. Mr Soh Kong Pheng Chairman, WSH Council (Industry Capability Building) Committee Chief Executive, Defence Science and Technology Agency

Mr Soh Kong Pheng is the Chief Executive of the Defence Science and Technology Agency. Prior to that, Mr Soh was in the Republic of Singapore Air Force since 1972 and was deployed to the Ministry of Defence as Director Defence Material Organisation in 1998.

When MINDEF restructured and established the Defence Science and Technology Agency as a new Statutory Board, he was appointed as Deputy Chief Executive (Operations). DSTA undertakes project management for acquisition and technology projects as well as systems development in the niche areas of command and control software and protective structures. Mr Soh's responsibilities are largely similar, and he continues to be primarily responsible for over-seeing the management of acquisition projects for MINDEF and the SAF.
